- 3.2 Your subscription to the Resources will automatically renew at the end of the term of your subscription unless terminated early by us or you.
- 3.3 Auto-renewing your subscriptions requires payment prior to the expiry of the term of your subscription. We will send you an email within a reasonable time before the expiry of your subscription to let you know your subscription is close to ending, and will also notify you of any changes to the price of subscription that will apply upon this renewal. You can opt-out of this service at any time by contacting us.
- 3.4 For the purpose of auto-renewing your subscription, we will charge your credit card or PayPal account that you previously provided to us. If payment fails, we may attempt to notify you and request that you update your payment details.
- 3.5 Your subscription will automatically renew at the expiry of your subscription for a further term, unless you cancel your subscription. We will contact you prior to the end of the term of your subscription.

- 3.6 If you choose to cancel your subscription to the Resources within the term of your subscription, or we decide to terminate your subscription due to your breach of the Agreement, you will not be refunded a percentage of the price of your subscription.
